Until now, no satisfactory and scientifically reliable compilation of the principle sources of the history of the Law of Nations has existed. **Fontes Historiae Iuris Gentium** is a 3-volume collection of all types of written testimony (including treaties, declarations, statutes and laws, and maritime documents) covering historical developments from antiquity to the end of World War II. In this work, the original documents are reproduced first, followed by a translation in both English and German (where the original document is not in either language). Separate Tables of Contents provide subject and chronological access to the wealth of material presented, while numerous subheadings throughout the text facilitate quick orientation.

The documents, or parts thereof, presented in these volumes have been selected from the enormity of material available by Dr. Wilhelm Grewe, whose widely acclaimed work, *Epochen der Völkerrechtsgeschichte* (Epochs of the History of the Law of Nations), published in 1984, forms the theoretical basis on which the present work is organized.

This work, arranged alphabetically by jurisdiction, provides the user with relevant information on sources of foreign law including complete bibliographic citations to legislation, the existence of English translations whenever possible, indications of currentness of the legal materials listed, and finally, selected references to secondary sources in English.

Each section contains an introduction which describes the particular country's legal system and mentions the major English-language books on the laws of that country. A subject breakdown with citation to primary sources and

translations enables the user to ascertain what laws are operative in a particular subject area.

Volume 1, published in December 1989, covers the Western Hemisphere. Volume 2, published in July 1991, covers Western and Eastern Europe and the European Communities. Volume 3, to be published in December 1992, will cover Africa, Asia and Australia.

The Carriage of Goods by Sea Act was enacted to achieve international uniformity in the law governing bills of lading, but lack of access to many of the background materials has caused judges and lawyers who deal with COGSA largely to ignore this wealth of information. intended meaning by organizing all materials for easy reference.

Editorial notes before each document (or groups of documents) explain individual points of interest, and the historical introduction places all sources in their appropriate context. International sources are reprinted here, including translations when necessary.
