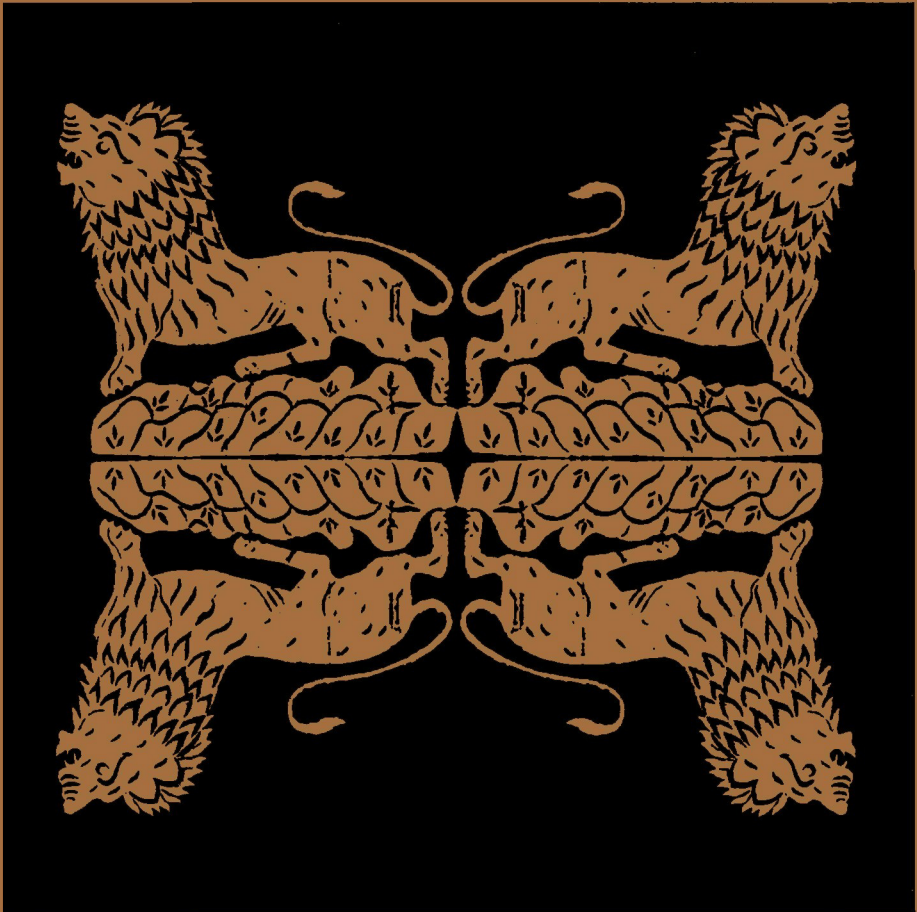

## CONTRIBUTORS TO THIS ISSUE

RAYMOND A. ANSELMANT is Professor of English at the University of Connecticut. The author of *Betwixt Jest and Earnest* (Toronto, 1979) and the editor of Thomas Taylor's *Christ Revealed*, he has also published a number of essays on sixteenth- and seventeenth-century political and satiric literature. The essay in this issue reflects his interest in literary reactions to the Caroline decades.

JAMES BRADLEY is Assistant Professor of Church History at Fuller Theological Seminary, Pasadena, California. He is the religion section editor of *The Eighteenth Century: A Current Bibliography* and currently is working on a study of English Nonconformity and the American Revolution.

ANGUS HAWKINS is Visiting Assistant Professor of Modern British History at Loyola Marymount University, Los Angeles. His most recent publication is "A Forgotten Crisis: Gladstone and the Politics of Finance During the 1850s," *Victorian Studies*, 26:3 (1983). He has recently completed a study of mid-Victorian politics and now is working on a reappraisal of the political career of the fourteenth Earl of Derby.

FATHER JOHN J. LaROCCA is Associate Professor and Chair of the Department of History at Xavier University, Cincinnati. He is the author of "Time, Death, and the Next Generation: the Early Elizabethan Recusancy Policy, 1558–1574," *Albion* (Summer, 1982), and is finishing a study of the enforcement of the recusancy statutes in Middlesex during James's reign.

KATHLEEN McCURONE is Associate Professor of History at the University of Windsor. She has published several articles on Victorian women in *Canadian Historical Papers* and *Atlantis*, and currently she is working on a book manuscript, "The Physical Emancipation of Women: Victorian Women and Sport, 1870–1914."

MAVIS MATE is Associate Professor of History at the University of Oregon. She has just completed a study of the estates of Canterbury Cathedral Priory in the thirteenth and fourteenth centuries, and has published on this subject the following articles: "The Indebtedness of Canterbury Cathedral Priory, 1215–1290," *Economic History Review* (1973); "The Impact of War on the Economy of Canterbury Cathedral Priory, 1294–1340," *Speculum* (1982); "Coping with Inflation: A fourteenth century English example," *Journal of Medieval History* (1978); and "The farming out of Manors; A new look at the evidence of Canterbury Cathedral Priory," *Journal of Medieval History* (1973).

**DAVID WRENCH** is Senior Lecturer in History at Bolton Institute of Higher Education. He is the author of "The Influence of Neville Chamberlain on Foreign and Defense Policy, 1932–39." At present he is working on the evolution of the Government of India Act of 1935.
