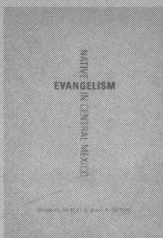
Land, Livelihood, and Civility in Southern Mexico

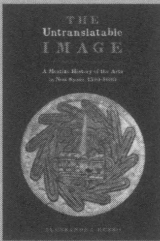

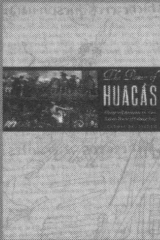

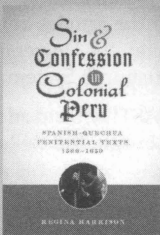
The Power of Huacas
