

NOTES ON THE CONTRIBUTORS

PHILIP MAUCERI is Assistant Professor in Residence at the Centers of Latin American Studies at the University of Northern Iowa. The author of *State under Siege: The Limits of Policy-Making in Peru, 1973–1990* (forthcoming) and coeditor of *The Peruvian Labyrinth* (forthcoming), his current research focuses on military rebellions in Peru, Venezuela, Ecuador, and Argentina.

JAMES BRENNAN teaches history at Georgetown University. His book, *The Labor Wars in Córdoba, 1955–1976: Ideology, Work, and Labor Politics in an Argentine Industrial City*, was published by Harvard University Press last fall. He is currently working on a study of Peronism and recent social science writing on Argentina.

LUIS MARTINEZ-FERNANDEZ is Assistant Professor of History in the Department of Puerto Rican and Hispanic Caribbean Studies and the Department of History at Rutgers University in New Brunswick. He recently published *Torn between Empires: Economy, Society, and Patterns of Political Thought in the Hispanic Caribbean, 1840–1868* and is now preparing a book-length manuscript on the links between politics and religion in nineteenth-century Cuba, Puerto Rico, and the Dominican Republic.

CESAR J. AYALA is Assistant Professor in the Department of Puerto Rican, Caribbean, and Latin American Studies at Lehman College, City University of New York.

ANDREW NICKSON is a senior lecturer in development economics on the faculty of the Development Administration Group, School of Public Policy, University of Birmingham, England. He has published three books on Paraguay, the most recent being *Historical Dictionary of Paraguay* (1993).

W. E. (TED) HEWITT is Associate Professor of Sociology at the University of Western Ontario in London, Canada. He has written *Base Christian Communities and Social Change in Brazil* and numerous articles on religion and politics in Latin America. He is currently studying the implications of international municipal-exchange programs for urban development in Brazil and other developing countries.

DAVID PION-BERLIN is Associate Professor of Political Science at the University of California, Riverside. He has published widely on political repression and human rights, military rule, military political thought, and civil-military relations. The author of *The Ideology of State Terror: Economic Doctrine and Political Repression in Argentina and Peru* (1989) and numerous articles and essays, he is now making a comparative study of military policy under democratic rule in the Southern Cone.

MARTIN DISKIN, Professor of Anthropology at Massachusetts Institute of Technology, has studied Mexico and Central America for the past thirty years.

MARGARET S. SHERRADEN is Assistant Professor in the Department of Social Work and Research Fellow at the Public Policy Research Center at the University of Missouri in St. Louis. She has written on health policy in Mexico and is

currently studying immigration and reproductive issues among women of Mexican descent.

SHERRIE L. BAVER is Chair of the Department of Latin American and Hispanic Caribbean Studies at the City College of the City University of New York. She is the author of *The Political Economy of Colonialism: The State and Industrialization in Puerto Rico* (1993) and co-editor of *Latinos in New York: Communities in Transition* (forthcoming).

JOSE O. DIAZ teaches and catalogs Latin American materials at the Ohio State University in Columbus. His current research is focused on the first elected governor of Puerto Rico, Luis Muñoz Marín, and on compiling an annotated bibliography on the country's political status.

CONSUELO CRUZ SEQUEIRA, a Nicaraguan, is a visiting fellow at the Center of International Studies at Princeton University and a contributor to the *New Republic* and the *Washington Post*.

BARBARA A. TENENBAUM is currently the specialist in Mexican culture in the Hispanic Division of the Library of Congress. She is also editor-in-chief of the *Encyclopedia of Latin American History*, a four-volume work to be published by Charles Scribner's Sons. She has published a number of works on nineteenth-century Mexican history, including *Politics of Penury: Debts and Taxes in Mexico, 1821–1856*.

PETER V. N. HENDERSON is Associate Professor of History at Winona State University in Minnesota. He wrote *Félix Díaz, the Porfirians, and the Mexican Revolution* and is presently working on a study of Francisco León de la Barra and the early years of the Mexican Revolution.

STEPHEN D. GLAZIER is Professor of Anthropology at the University of Nebraska, Kearney. He has edited three volumes, the most recent being *Anthropology of Religion: A Handbook of Method and Theory* (1994).

ROBERT B. KENT, an associate professor of geography and planning at the University of Akron, was a Fulbright Scholar in Argentina in 1993 and is currently heading the Conference of Latin Americanist Geographers (CLAG). His research and teaching interests include regional development, planning, cartography, and the cultural and economic geography of Latin America, particularly the Andean region.

ALLAN METZ is Assistant Professor and Reference Librarian at Drury College in Springfield, Missouri. The compiler of *Bill Clinton's Pre-Presidential Career: An Annotated Bibliography* (1994) and *North American Free Trade Agreement: An Annotated Bibliography* (forthcoming from Greenwood Press), he has also published articles in a variety of journals on Latin America and the Clinton presidency.
