

#### Journal Announces Prize Competition

In science today one principal mode of advancement of understanding is by means of generating valid solutions to specific problems. The editors of the *Journal of Social and Biological Structures* believe there is now both the need and the capability to produce effectively many models of human capacity which will be more sophisticated and more facilitated than those of the past. Today, an adequate model must rely upon both the social and the biological sciences.

The journal is offering an annual prize of \$5,000 for the best paper submitted in competition concerning a model of this sort. Any paper entered in the competition must be original, submitted for publication in the *Journal of Social and Biological Structures* and not submitted to any other journal.

Most submissions will deal with preliminary or partial aspects of the author's model; however, the journal will not discourage more systematic attempts.

The first award will be for papers submitted in 1982-83. The award will be made annually for a minimum of five years.

## Ford Papers Opened for Research

Approximately half of the Ford presidential papers were opened to research April 5 at the Gerald R. Ford Library, the sev-

enth presidential library operated by the National Archives and Records Service, General Services Administration. The newly opened materials include most of the White House Central Files, files of the Assistant to the President for Domestic Affairs and all Domestic Council staff, legislation case files, and Energy Resources Council records. Almost all presidential concerns except foreign affairs and defense issues are well represented in the open materials. The Ford audiovisual collection, congressional and vice presidential papers, and the records of the Council of Economic Advisers had been previously opened.

Beginning in late 1982, the Gerald R. Ford Foundation plans to award grants for research based substantially but not solely on Library holdings. ## Bowling Green Opens Policy Center

Bowling Green State University announces the founding of its Social Philosophy and Policy Center (originally called the Institute for Social Philosophy and Policy). The Center, which has been established with grants of \$331,000 from several private foundations, will employ the talents of philosophers and political scientists in order to investigate a variety of public policy questions. In this connection it will publish a monograph series, Studies in Social Philosophy and Policy, as well as a journal entitled Social Philosophy and Policy. ### Science Foundation Publishes Manual

A manual describing how University/ Industry Cooperative Research Centers work and how to start one has been published by the National Science Foundation's Division of Industrial Science and Technological Innovation.

The centers are university-based, typically interdisciplinary, programs of research supported jointly by a number of companies. The program stimulates industrial support of university research through the establishment of centers that create long-term collaboration between the university and industry in research areas of mutual interest. Research programs are co-funded by groups of industrial firms in areas that are compatible with university research objectives and also responsive to industry needs.

Six Industry/University Cooperative Centers are now operating; one already is self-sufficient.

### Western Association Elects Peter Lupsha

Peter Lupsha of the University of New Mexico has been elected vice-president and president-elect of the Western Political Science Association.

Lupsha received his Ph.D. from Stanford University in 1967, taught at Yale University for five years and then came to the University of Mexico. The vice-president of the Western Association is also program chair for the 1983 Western meeting, which will be held in Seattle, March 24-26.

## NEH Grants Still Available

It seems that the bad news about Reagan's proposed cuts has travelled much more quickly than the good news about the victories the National Endowment for the Humanities (NEH) has won this year. Although this year's NEH budget is only \$20 million less than last year's, people seem to be under the impression that it is impossible to get an NEH grant anymore. With the exception of a few programs which have been discontinued, this is most definitely not the case.

## Cox Finishes Book on Election Data

The Institute of Public Administration, Department of Political Science at Indiana University, has published The Representative Vote in the Twentieth Century by Edward Franklin Cox. This volume, which extends and completes a project that resulted in Cox's State and National Voting in Federal Elections, 1910-1970, provides Congressional election data between 1900 and 1978. This new volume, 617 pages in length, gives election data for all candidates of all parties for all elections, both regular and special, to the House of Representatives. The data are broken down by district, with special care given to redistricting.
