CONTRIBUTORS

Thomas E. Hill, Jr., is Professor of Philosophy at the University of North Carolina at Chapel Hill, where he has taught since 1984. He previously taught for sixteen years at the University of California, Los Art yliciosici more briefly at Pomona College, Johns Hopkins University, and iting appointment) at Stanford University. He is the author of the Practical Reason in Kant's Moral Theory (Cornell University Press, 1962), and Autonomy and Self-Respect (Cambridge University Press, 1991), which are collections of essays on Kant's ethics and various moral problems.

Christine M. Korsgaard is Professor of Philosophy at Harvard University, where she received her Ph.D. in 1981. She has taught at Yale, the University of California, and the University of Chicago. Her published essays concern the ethical theories of Kant, Aristotle, and Hume, and contemporary discussions of the relationship between ethics and practical reason. Her current research projects include the development of a Kantian account of personal relationships and an investigation into the ways in which moral philosophers have attempted to establish the normativity of ethics.

David Schmidtz is Associate Professor of Philosophy at Yale University. He is the author of *The Limits of Government: An Essay on the Public Goods Argument* (Westview Press, 1991). His essay in this volume is part of a larger project on the subject of rational choice and moral motivation.

Robert Sugden is Professor of Economics at the University of East Anglia, England. Born in 1949, he trained at the Universities of York and Wales, and has taught at the Universities of York and Newcastle upon Tyne. He has done research on welfare economics, social choice, the evolution of social conventions, choice under uncertainty, and experimental economics. Currently, he is particularly concerned with the role of rationality assumptions in economics. His most recent book is *The Economics of Rights*, *Co-operation, and Welfare* (Basil Blackwell, 1986).

Neera Kapur Badhwar is Assistant Professor of Philosophy at the University of Oklahoma. She received her Ph.D. from the University of Toronto in 1986, and was a Killam Postdoctoral Fellow at Dalhousie University in 1986-87. She has published articles in American Philosophical Quarterly, Philosophy and Phenomenological Research, Journal of Political Philosophy, Ethics, Dialogue, and Logos, and has an anthology on the philosophical dimensions of friendship forthcoming from Cornell University Press.
