The Baka are one of the Indigenous groups represented by Gbabandi, a platform of forest Indigenous Peoples that has initiated a dialogue with key conservation actors to work towards community-led, rights-based conservation. The importance of human rights in conservation is receiving renewed attention through prominent inclusion of rights in the Kunming–Montreal Global Biodiversity Framework, which was adopted by the Conference of the Parties to the Convention on Biological Diversity in December 2022. In the lead article, Baka author Timothée Emini and colleagues from the Forest Peoples Programme describe how an Indigenous-led listening event has helped conservation decision makers better understand the effects of their decisions. Journals play an important role in advancing standards related to rights, and the articles in the human rights and conservation theme of this issue of *Oryx* contribute to these advances, including by addressing the right of local and Indigenous people to participate as authors in the peer-reviewed literature.
