This manual is based on a revolutionary principle. Multilingual terminology is no longer treated as a science devoted to the explanation of the meaning of terms in different languages, but as one built on the elucidation of the equivalence in the multilingual plane of identical concepts. The latter are the starting point of the investigation, not isolated single terms. Consequently, they must be presented within the framework of a coherent system of concepts, and that is the reason why Dr. Paenson's manual assumes, in fact, the form of concise treatises - centred on terminology - of the discipline considered. Thus, the search for the meaning of given words is replaced by the quest of terms to express a given idea.

This presentation of terms within their logical context forming part of a wellstructured system of ideas has many advantages, particularly for terms pertaining to social sciences: these latter terms have very often several meanings and only their context can allow a rational choice. Within a logical system of terms the latter also shed light on each other. This approach, corresponding to the normal associative way of thinking, is also the only rational one from the mnemotechnical point of view: it facilitates the assimilation and memorization of terms. Last, but not least, it also makes it easier to expose varying - sometimes ver widely - interpretations of a given term, conditioned by differences in philosophy and methods of expression. **June 1983** 894 pp. Clothbound
