## 1981-82 APSA Black Graduate Fellowships

The Association has announced winners in the competition for the 1981-82 Black Graduate Fellowships in Political Science.

The winners include three fellows to receive scholarships of \$4,700 for the academic year 1981-82 to attend the university of their choice and three non-funded fellows. The non-funded fellows have been recommended to graduate departments of political science as deserving of consideration for fellowships or other financial assistance.
