## ASIAN studies Program

## Research Compendium

A Compendium of some 70 abstracts has recently been completed. Research in Progress on the Community was prepared by Terry N. Clark for the Committee for Community Research, International Sociological Association and the Committee for Community Research and Development, Society for the Study of Social Problems. ## FRENCHEAmerican Clearing House

The Franco-American Commission for Educational Exchange (Fulbright Commission in France) is organizing a clearing house service to create direct teaching exchanges between French and American universities.

The purpose of this service is (1) to determine which French and American establishments of higher learning would be willing to exchange members of their teaching staff; (2) to put the interested department chairmen of these institutions into direct contact, for prospective negotiations of individual professor exchange agreements; (3) to inform American university officials or individual American professors as to ways and means of reaching the best possible exchange contracts with French universities.

In order to provide an incentive for the project, the Franco-American Commission will set aside each year a number of round trip travel allowances for individual French and American exchange lecturers.

The clearing house project has been discussed with officials of the French Ministry of Education, and an inquiry has been made among presidents and department chairmen in French universities. The proposal was very well received in French governmental and academic circles and it was agreed that the most generally acceptable exchange system would be the following:

A French university inviting an American professor to teach in one of its U.E.R.'s (U.E.R., meaning '"Teaching and Research Unit", is the French equivalent of the American university department) would pay him the salary normally provided to a French staff member of corresponding rank. In order to create an available post, a French professor from the same U.E.R. would then be invited by the American lecturer's home institution, which would in turn offer the French lecturer the salary corresponding to his university rank.

No limitation has been made with regard to academic disciplines or duration of appointments, although in the latter case, agreements covering one academic year or at least one semester seem generally to be preferable.

It is a known fact that French professors' salaries are substantially lower than those of their American colleagues. However, a fiscal convention between the two countries provides tax exemption for visiting lecturers of both nationalities. In addition, the French government system of "social security" offers comprehensive coverage in terms of sickness and accident insurance.

## social Science Citation Index

A new index designed to improve access to information published in the social sciences and humanities journal literature has been announced by the Institute for Scientific Information.

Beginning in 1973, ISI will offer a Social Sciences and Humanities Citation Index covering articles, book reviews, and correspondence appearing in approximately 600 key journals in the fields of anthropology, community health, demography, economics, educational research, ethnic studies, geography, history, law, linguistics, management, marketing, political science, psychiatry, psychology, sociology, statistics, and urban planning/ development.

The Social Science index will be patterned after ISE's widely used Science Citation Index. Citation indexing is based on the fact that current articles referencing the same earlier publication have a subject relationship not only with the earlier work but also with each other. To utilize this relationship, a citation index lists together all articles published during a specified time period that reference the same earlier publication. In effect, the earlier work becomes an indexing term by which someone who is familiar with its content may look up new articles on the same subject.
