The *JOURNAL SERIES B*. This series contains papers on applied mathematics. It is published in volumes comprising four parts, starting with Volume XIX Part 1, 1975. The *BULLETIN* of the Australian Mathematical Society began publication in 1969. It aims at quick publication of original research in all branches of mathematics. Two volumes of three numbers are published annually. The price to non-members is A\$250 (US\$192) for 1995. Each paper for publication should include an abstract and a 1991 Mathematics Subject Classification. Three copies of the typescript should be sent to the Editor, Dr. A. S. JONES, Department of Mathematics, University of Queensland, QLD 4072, Australia.

The *GAZETTE* started publication in 1974 and carries news items, mathematical articles of general interest, and articles on tertiary mathematics teaching.
