Call for Manuscripts

Themed Issue on Diversity, Equity and Inclusion in Clinical and Translational Science

We are issuing this Call for Papers for a special themed issue of the *Journal of Clinical and Translational Science* which will focus on **Diversity, Equity, and Inclusion in Clinical and Translational Science**. Our goal is to curate a set of manuscripts that highlight advancements in Diversity, Equity, and Inclusion in clinical and translational science, particularly regarding promoting diverse research leaders, developing diverse trainees, funding, and promoting health equity-oriented research, and ensuring clinical trials research participants reflect the underlying racial/ethnic diversity of our nation.

We strongly encourage submission of a summary (3-6 sentence summary of the topic and/or work) by January 15, 2022, to ensure your paper fits the issue's theme. In addition, if we identify duplicate concepts, this provides us an opportunity to link authors together to develop a collaborative paper. Manuscript submissions will be received through April 30, 2022. Authors who do not submit a summary may still submit a manuscript for consideration for inclusion in the themed issue.

Manuscripts must be written for a broad target audience of all translational researchers. To ensure this, reviewers will include both clinical and translational researchers and health equity researchers for each manuscript. Manuscripts will be accepted from across the spectrum of Diversity, Equity, and Inclusion related topics, with a focus on data-based manuscripts, as well as systematic, narrative and scoping reviews, though the domains below are of particular interest.


- Promoting diverse research leaders
- Developing diverse trainees
- Funding and promoting health equity-oriented research
- Ensuring clinical trials research participants reflect the underlying racial/ethnic diversity of our nation.
- Building community capacity for research and improving public understanding and trust in science
- Ensuring diversity of lived experiences is represented in funding priorities and on research teams

Submissions should be made online via the Journal's ScholarOne submission site. Authors are asked to select "Diversity, Equity and Inclusion in Clinical and Translational Science" in the Themed Issue submission question when submitting to this issue.
