



The COVID-19 pandemic has made unpaid care more visible through its absence, while also increasing the need for it. Drawing on a range of research projects covering Canada, Germany, Norway, Sweden, the UK and the US, this book documents a broad spectrum of unpaid work performed by residents, relatives, volunteers and staff in nursing homes.

It demonstrates how boundaries between paid and unpaid work are flexible, varying considerably with conditions, time, place and intersectional populations.

By examining the complex labour process within nursing homes, this book provides insight and understanding which will be critical in planning for nursing home care post-pandemic.


India's ageing population is growing rapidly; over 60s constitute 7 per cent of the total population and this is projected to triple in the next four decades.





When she's unexpectedly asked out on a date and finally capitulates, two septuagenarians discover an unexpected world of dating and intimacy. Mary's story is the new norm, and with barriers to later life sexuality removed what could go wrong? Plenty, with the number of sexually transmitted infections growing among over-65s (up

by 20% from 2017-19 according to a Local Government Association report).

Never Too Late covers a host of crucial topics, including:

- How to identify the signs and symptoms of different STDs, including newer infections
- The importance of regular screening
- Best sexual practices, including guidance on medications
- Preventative measures, tests, and treatments

This book provides new insights into the challenges facing older people in the context of the COVID-19 pandemic.


It draws upon novel qualitative longitudinal research which recorded the experiences of a diverse group of people aged 50+ in Greater Manchester over a 12-month during the pandemic. The book analyses their lived experiences and those of organisations working to support them, shedding light on the isolating effects of social distancing.

Covering 21 organisations, as well as 102 people from four

ethnic/identity groups, the authors argue that the pandemic exacerbated existing inequalities in the UK, disproportionately affecting low-income neighbourhoods and Black, Asian and minority ethnic (BAME) communities.

The book outlines recommendations in relation to developing a 'community-centred approach' in responding to future variants of COVID-19, as well as making suggestions for how to create post-pandemic neighbourhoods.



As the number of older people around the world continues to increase, it is important for families, communities, governments, and nations to have a better understanding of their older adults and their unique contributions, as well as their interests and needs, to ensure that they are able to age with dignity and respect and contribute to the overall health and well-being of their people and environments. The volume will include chapters from authors representing Indigenous populations from many parts of the world, who describe: 1) research studies on the

social aspects of aging among Indigenous populations, including cultural, social, and/or economic contributions of older Indigenous adults in their communities; 2) perceptions of aging and well-being among international Indigenous populations; 3) theories about Indigenous aging; and 4) policy and intervention practices (i.e., programs and services) related to older Indigenous adults. The book's chapters also point to current and emerging areas of tension and challenges facing Indigenous older persons due to economic, social and other changes in society.



It provides critical analysis of key policies and professional practice over three decades and highlights the continuing challenges faced by people in caring relationships, as well as reflecting on developments in the position of unpaid carers in the system of social care.

By questioning why this crucially important sphere of human life remains under-resourced, it sheds light on the ways in which care is understood and how policy makers and service providers perceive the need for support.



It also evaluates how local and global systems of inequalities influence retirement

migrants' experience, providing both opportunities and constraints that differ across countries.






This volume offers a unique exploration of how ageing masculinities are constructed and represented in contemporary international cinema.

It provides new perspectives across the intersections of old age, ethnicities, class and sexual and gender identity, paying particular attention to older men from seldom heard or marginalised groups.






The book compares key features of long-term care insurance (LTCI) schemes in 15 pilot cities and evaluates the sustainability of various financing models adopted by the cities in the LTCI schemes. The book uses an interpretive case study approach to give an in-depth look into the LTC models in three pilot cities – Qingdao, Nantong, and Shanghai. The three cities represent three different models of

financing and delivering LTC. To assess how effective the LTC models in these three cities are, the book uses five criteria, including utilization of medical resources, cost, equity, quality of care and sustainability. Also, the authors discuss how the financing and delivery of LTC can be improved in China, the impact of the 2019 coronavirus (COVID-19) pandemic on older adults in need of LTC in the country and the implications of China's LTCI reform for other countries.

The book will be a useful reference to scholars and policy-makers who look at urban ageing and healthcare costs and delivery.





in this area of growing importance. Part of this is appreciating how approaches to dementia care have evolved over time. In this context, the book discusses how the dominant bio-medical model has been challenged by person-centred and rights-based approaches. As a key part of social work is to offer people choices, the book provides information about a wide range of health, social care and other services that are available, whilst also highlighting the gaps that exist for different groups and in different areas. Case studies and activities help the reader apply theory to practice.



And how ought societies to respond to issues of social justice and the good, balancing the interests of generations and age cohorts? In this Cambridge Handbook, the first book-length attempt to stake this terrain, leading moral philosophers from a range of sub-fields and regions set out their approaches to the conceptual and ethical understanding of

ageing. The volume makes an important contribution to significant debates about the implications of ageing for individual well-being, social policy and social justice.



Japan is the fastest aging country, with the largest super-aged society in the world and growing larger by the day, yet its universal health care costs are relatively low. In Health Insurance Politics in Japan, Takakazu Yamagishi draws back the curtain for an international audience and investigates how Japan has been able to control health care costs through health insurance politics.

Covering the period from the Meiji Restoration to the Abe Administration, Yamagishi uses a historical institutionalist approach to examine the driving force behind the development of health insurance policies in Japan. Yamagishi pays special attention

to the roles of government and medical professionals, the main actors of the policymaking and medical worlds, in this development. Health Insurance Politics in Japan pushes Japan into the spotlight of the international conversation about health care reform.


The edited volume *Age and Work: Advances in Theory, Methods, and Practice* presents a systematic collection of key advances in theory, methods, and practice regarding age(ing) and work. This collection develops novel and useful theory, explains underutilized but important methodological approaches, and suggests original practical applications of emerging research topics.

The book begins with a prologue by the World Health Organization's unit head for aging and health, an introduction on the topic by the editors, and an overview of past, current, and future workforce age trends. Subsequently, the first main section outlines theoretical

advances regarding alternative age constructs (e.g., subjective age), intersectionality of age with gender and social class, paradoxical age-related actions, generational identity, and integration of lifespan theories. The second section presents methodological advances regarding behavioural assessment, age at the team and organizational levels, longitudinal and diary methods, experiments and interventions, qualitative methods, and the use of archival data. The third section covers practical advances regarding age and job crafting, knowledge exchange, the work/nonwork interface, healthy aging, and absenteeism and presenteeism, and organizational meta-strategies for younger and older workers. The book concludes with an epilogue by an eminent scholar in age and work.



Rowan Bayne and Carol Parkes take a pragmatic approach to reviewing what is happening in many aspects of your life as you age. Essential topics covered include mobility; diet and digestion; understanding and improving sleep; memory problems and dementia; being an active participant in consultations about your

own healthcare; attitudes to getting old; romantic relationships and loneliness; deciding where to live, moving house and choosing other types of living arrangements; and death and grief. They invite readers to focus on their own life and experience, to understand who they are and what they really want now. An important part of self-understanding is the application of personality theory to changes associated with getting old, and readers are encouraged to reflect on what might work for people with their personality characteristics, and how to improve their stress management, communication and decision making. With suggestions for further reading and useful organisations that offer support, Getting Old offers valuable, affirming guidance for all those and their relatives going through this life stage, as well as health, social care and counselling students and professionals.



Evidence shows that elderly victims are more likely to be attacked by strangers, most likely to be victimized in their own homes, and are usually less capable of resisting



The Future of Leisure and Retirement explores social support for the elderly in cross-cultural and historical contexts. Beginning with a comparison of various cultural traditions developed in complex societies from ancient times to modern, this vital new book argues that how a society values its aged citizens and views their contributions to society determines its willingness to provide for their support. Recently, an increasing number of U.S. companies have raided their pension funds to stay afloat or have closed them and transferred liability. Major changes to U.S. federal laws concerning pensions and the responsibility of corporations to fund

them have been made under the Pension Protection Act of 2006. Worldwide, workers' retirement payments are under assault, as are investments by pension funds due to laws governing priority of payment. The need for retirement support of some kind in the post-Covid-19 world will require new forms as well as the recovery of pre-Covid-19 savings and investments.



The dominant narratives of both science and popular culture typically define aging and human development as self-contained individual matters, failing to recognize the degree to which they are shaped by experiential and contextual contingencies. Our understandings of age are thereby "boxed in" and constricted by assumptions of "normality" and naturalness that limit our capacities to explore possible alternative experiences of development and aging, and the conditions – both individual and social – that might foster such experiences.

Combining foundational principles of critical social science with recent breakthroughs in research across disciplines ranging from

biology to economics, this book offers a scientifically and humanly expanded landscape for apprehending the life course. Rejecting familiar but false dichotomies such as "nature vs. nurture" and "structure vs. agency", it clarifies the organismic fundamentals that make the actual content of experience so centrally important in age and development, and it also explores why attention to these fundamentals has been so resisted in studies of individuals and individual change, and in policy and practice as well.



One of these goals looks at health and wellness. Ageing populations have become a crucial issue worldwide, and this short monograph explores ageing and how the consequences of an ageing population may affect our healthcare system through a case study on Hong Kong's population.

The book looks at several critical health issues related to ageing. The elderly, particularly those with low socio-economic status, rely more on acute-centric care rather than primary care. The book suggests

that secondary care service may only be effective to a limited extent as a healthcare measure and an optimum healthcare system should be one that focuses on primary care. The authors put forth a compelling argument for disease prevention and screening schemes and explain how they are more cost-effective and beneficial to society and the system.

This thoughtful book will provide beneficial insights into the relationship of ageing and Sustainable Development Goals in the context of health and wellness for policymakers and healthcare professionals.






